2019 POOL PARTY POLICY AND REQUEST FORM

COST: The Mammoth Pool can be reserved for private pool parties starting May 10, 2019

- \$175 for 2 hours, \$250 for 3 hours, \$325 for 4 hours (maximum pool party time is 4 hours)
- The time includes set up and clean up time.
- Up to 80 attendees maximum – this includes both swimmers and non-swimmers. If additional lifeguards are needed, the cost will be \$50/lifeguard.

2. Forms are to be submitted ***at least one week before the party*** and parties are not considered officially booked until forms have been received, a \$50 (refundable) cash deposit has been paid, and the pool party fee has been paid.
3. Submit this signed form with your check/cash for the party fee and the \$50 cash deposit at Town Hall.

TOWN OF MAMMOTH POOL PARTY

RELEASE OF LIABILITY, WAIVER OF LIABILITY AND INDEMNIFICATION

I agree that when using the Town of Mammoth swimming pool, I will comply with all the covenants, conditions, restrictions, rules and regulations regarding the use of the swimming pool. In addition, I will make a reasonable effort to ensure that my family, guests, invitees, agents and employees will comply with all the covenants, conditions, restrictions, rules and regulations regarding the use of the swimming pool. These rules and regulations include, but are not limited to: All persons are required to abide by the posted swimming pool rules and the attached pool party rules. Persons under the age of eight (8) must be accompanied at all times in the swimming pool, or pool grounds by a person who is at least thirteen (13) years of age. There shall be no glass containers on the pool grounds; there shall be no food in the swimming pool; there shall be no drinks in the swimming pool. There shall be no animals in the swimming pool or table area. Drugs, alcohol, and tobacco (including e-cigarettes) are not allowed on the property. Party participants under the influence of drugs or alcohol will be asked to leave the pool property.

I understand that using the swimming pool is potentially dangerous, and could cause personal injury or death. I hereby agree that the use of the Town of Mammoth swimming pool is at my own risk. In consideration of my use of the Town of Mammoth swimming pool, I knowingly and voluntarily agree to defend, indemnify and hold harmless the Town of Mammoth, its employees, officers, directors, agents, members, management and staff, from and against all actions, causes of action, suits, claims and demands whatsoever, and from all cost, damages, losses, expenses, charges, debts, judgments, orders, penalties and liabilities whatsoever, including attorney's fees and costs that arise out of, relate to, or result from the use of the Town of Mammoth swimming pool, by myself, or by my family, guests, invitees, agents, or employees, including, but not limited to, personal injury, death, property damage, negligence and any other tortuous act of omission.

On behalf of myself and my personal representatives, assigns, spouse, family, heirs and next of kin, I hereby release Town of Mammoth, its employees, officers, directors, agents, members, management and staff, from and against all actions, causes of action, suits, claims and demands whatsoever, and from all cost, damages, losses, expenses, charges, debts, judgments, orders, penalties and liabilities whatsoever, including attorney's fees and costs that arise out of, related to, or result from the use of the Town of Mammoth swimming pool, by myself, or by my family, guests, invitees, agents, or employees, including, but not limited to, personal injury, death, property damage, unlicensed activity, violation of any statute, law, rule or ordinance, misconduct, negligence and any other tedious act of omission.

I understand that this waiver is intended to be as broad and inclusive as permitted by the laws of the State of Arizona, and I agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be in the State of Arizona.

I have completely read, understand, and voluntarily acknowledge this Release of Liability, Waiver of Liability and Indemnification, and further acknowledge that no oral representatives or statements apart from this written agreement have been made to or relied on by me.

TOWN OF MAMMOTH POOL PARTY RULES

1. The pool manager or on-duty lifeguard will be in charge of the pool party and responsible for the enforcement of the swimming pool and pool party rules and regulations.
2. Children 8 and under must be accompanied by a mature, responsible person 13 years or older.
3. Persons with a cold, skin or other body infection, open wound, diarrhea, or other contagious condition will not enter the pool.
4. Infants and toddlers who are not potty trained must wear tight-fitting rubber or plastic pants or a swim diaper.
5. Running, scuffling, "dunking" or horseplay will not be allowed. No diving in shallow end.
6. The water area in front of the diving board must be kept clear. No diving will be permitted from the side of the board, and no repeated bouncing or hanging on the board will be allowed. Flips or other unsafe jumps off the diving board are not allowed.
7. Pool games and activities will be allowed at the discretion of the lifeguard. Any game or activity that becomes too rough or dangerous will be stopped immediately.
8. Facemasks or goggles made with glass will not be allowed in the pool. Floatation devices attached to the swimmer for safety are allowed in the shallow end only and only when accompanied by a responsible person.
9. No food, drink, bottles, or gum chewing is permitted on the pool deck. Food and drinks are only permitted in the table area, and only in unbreakable, non-glass containers.
- 10. No drugs, tobacco or alcoholic beverages will be allowed on the property. No persons under the influence of alcohol or drugs will be allowed on the swimming pool property.**
11. The Town of Mammoth is not responsible for accidents or for lost or missing articles.
12. Anyone guilty of violations of pool party rules or pool rules may be asked to leave the pool property.
13. The pool closes at 10 pm (no exceptions).
14. The \$50 cash deposit will be refunded once the party is over and it is determined by the Pool Manager that there are no additional costs owed to the Town of Mammoth.
