



RESOLUTION NO. 2020-02

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF MAMMOTH, ARIZONA INCREASING RATE, RATE COMPONENT, FEE, AND SERVICE CHARGE INCREASES FOR THE TOWN OF MAMMOTH SEWER SERVICE.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF MAMMOTH, ARIZONA, AS FOLLOWS:

WHEREAS, pursuant to Arizona Revised Statute § 9-511.01, the Town Council of the Town of MAMMOTH, Arizona published a Notice of Intention for the Town of MAMMOTH sewer rate increase; and

WHEREAS, the Town Council of the Town of MAMMOTH, Arizona conducted a public hearing on November 21, 2019 on the proposed increases for rates, rate components, fees and service charges for the Town of MAMMOTH sewer, after publication of notice thereof as required under Arizona law.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of MAMMOTH, Arizona as follows:

Section 1. Findings.

(a) The Town of MAMMOTH, Arizona (the "Town") has the requisite statutory authority to acquire, own and maintain sewer utility services for the benefit of the property and users within and without the Town's corporate boundaries pursuant to the provision of Arizona Revised Statutes §§9-511 et. seq.

(b) The Town has caused to be prepared a written report (the "Sewer Rate Report"), which report concludes that certain increases in rates, rate components, fees and service charges for use of the Sewer System are necessary to support the maintenance and development of the Sewer System.

Section 2. Establishment of Increased Rates and Charges. The rates, rate components, fees and service charges described in Section 3 are hereby adopted and established as the rates, rate components, fee and service charges for sewer service, effective January 1, 2020, and until subsequently changed by this Mayor and Council. Such increased rates, rate components, fees and service charges, when effective, will supersede previous rates, rate components, fees and service charges for the Sewer System pertaining to the specific rates, rate components, fees and service charges. The Town Council has the authority to adjustment all rates, rate components, fees and service charges on a yearly basis based on the consumer price index utilizing the Western Urban index for all urban consumers.

Non-Residential Commercial	\$24.31	\$42.50
Late Fee – Monthly		\$25.00


