

NOTICE OF A SPECIAL MEETING OF THE MAMMOTH TOWN COUNCIL March 8, 2013

Minutes of a Special Mammoth Town Council Meeting held March 8, 2013, pursuant to the notice required by law.

1. Call to Order

Mayor Barcelo called the meeting to order at 6:00 p.m.

4. Call to Public

Rene Romo stated that he opposed the purchase of the crack sealing machine (item 5-A.1 &2 on the agenda) for various reasons.

- 5. New Business Discussion and/or action on the following:
 - A. Public Works Department David Garcia
 - Approval to purchase a Crafco SS125 Melter OFF HGAC- Cost \$59,570.43

PW Director David Garcia asked the Council to "table" this item and item 5-A.2, and stated that he would rather put the Public Works' crew back to 40 hours per week, rather than purchase the crack sealing machine.

2. Approval to purchase Crafco Crack Seal Mix -Cost \$21,826.37

Councilwoman Medina motioned to table items 5. A #1 & 2. A second was made by Councilman Barcelo. Motion passed.

3. Approval to purchase 16 pallets of Type II Portland Cement - Cost \$4564

Councilman Barcelo motioned to purchase 16 pallets of Type II Portland Cement costing \$4564. A second was made by Councilwoman Medina. Roll Call vote: Councilman Barcelo – Yes; Councilman Gallego – Yes; Mayor Barcelo – Yes; Councilman Brewer – No; Councilwoman Medina – Yes. Motion carried – 4 Yes votes to 1 No vote.

Councilman Barcelo motioned to declare the listed vehicles and bumpers surplus and advertise in the Miner Newspaper. A second was made by Councilman Gallego. Motion passed.

Councilman Barcelo amended the motion to include advertising in the Miner Newspaper for 2 weeks. Seconded by Councilman Gallego. Motion passed.

B. Discuss Casino – Adopt Resolution No. 2013-01

Councilwoman Medina motioned to adopt Resolution No. 2013-01, support construction of the Casino near Aravaipa. A second was made by Councilman Barcelo. Motion passed.
