

# 7. NEW BUSINESS-Discussion and/or action on the following:

A. Sewer Lines on private property-Rogina Medina

Mrs. Medina presented map she made showed and discussed the problem at 502 Vine Ave., that a sewer line is under their home and that neighbor's private sewer line is run through their property to connect to that main line. One of those lines that belong to a neighbor at 500 Vine Ave. is leaking and needs repair.

The main question is ownership of that line, although it is on her property it is the neighbor's line, the neighbor has refused to pay for thee repairs. Public Works Interim, Pablo, is having difficulty finding the original maps for Little Hollywood subdivision.

The commission consensus was IF needed the Town of Mammoth approved a main sewer line be placed on private property they indeed she be responsible for that line, and further that the neighbor should be responsible for their line.

Evette Romero motioned to hold a Special Meeting on May 14, 2015 at 6 p.m. to request presence of or recommendation from Public Works. A second was made by Sharon Christiansen. Motion passed.

B. Change of Ordinance from commercial to residential at 129 N. Main St. (Mammoth Bar)

Water Campion Diane Theobald told applicant only legal owner can apply for this change and this item information only. He understood that is what he wanted. He is a shop teacher in San Manuel and is looking for a property big enough to house his auto's personal only NOT for business purposes. The problem is financial commercial tax about 3 times residential.

After long discussion...Diane Theobald against rezoning and commercial property on Main St. to residential and that it would be extremely difficult to return it to commercial. Probably would not pass ordinance requirements.

Further discussion by commissioners Sharon Christiansen and Evette Romero, that it is time to realize that our Main St will not be viable for commercial businesses any more. Evette Romero also pointed out that many properties on Main St. are residential already.

Finally the consideration of floodplain came up.

Discussion from Councilman Sloan and motel owner, Violet Blankemeyer, (discussion wandered) chair called point to order.

Evette Romero made a motion to research Main St. to consider rezoning, from what portion to rezone. A second was made by Diane Theobald. Motion passed.

Diane Theobald will do research on this and further action of "field trip" possible. Thank you.

Chair did inform him that several of those items REQUIRED formal Planning and Zoning agenda action. Including the question od Marijuana dispensary.
