There are also concerns about safety issues in relation to the open doors and refrigerator on property. Second is the Franco property there has been 3 complaints on this occupied property. Also on Verdugo is the Rock house near Kino which has complaints as well. These will all be managed by Kim Lee.
- b. San Manuel Drive is back on the list this year, the mobile next to Mary Reynoso is become an issue there has been a break in of a mobile in that area and movement has been noticed at this abandoned mobile. There is also a few other concerns in the New Mammoth area in which Diane Theobald will take the lead.
- c. Main Street is back on the board with 420 s. Main as well as issues on the Sharp Property concerning abandoned car and illegal travel trailer in the rear. They have been verbally warned and made promise to remove these problems by March 10<sup>th</sup> and as of today nothing has been done. The other complaint here is the old adobe across from the Lions Club and this is still in limbo due to the owner's declaration that it is a historic building. County says no but nothing has done nothing and the property is still in limbo. Walter Jones will tackle this area of town.
- d. Pinal Rural is up again, they have moved in more trailers instead of removing them. We have made numerous requests and are now out of options we must file a citation order giving them 2 weeks to comply before fines begin to accrue. Sharon Christiansen will work with this one.
