FOLLOWS:

1. TOWN WILL PROVIDE THE FOLLOWING TOWN SERVICES TO CUSTOMER AT THE SERVICE ADDRESS INDICATED ON THE NEW CUSTOMER SET UP FORM PRINTED ON THE FIRST PAGE OF THE DOCUMENT WHICH IS HEREBY INCORPORATED BY REFERENCE:

SERVICES SHALL BE PROVIDED IN ACCORDANCE WITH STATE LAW AND MUNICIPAL ORDINANCES AND RESOLUTIONS AS REQUESTED ON THE SET UP FORM, AT THE RATES ESTABLISHED BY ORDINANCE OR RESOLUTION OF THE MAMMOTH TOWN COUNCIL, PROVIDED THAT THE TOWN SHALL NOT BE RESPONSIBLE FOR FAILURE TO DELIVER SERVICES BY REASON OF STRIKES, ACCIDENTS, ACTS OF GOD, WEATHER CONDITIONS, NATURAL DISASTERS – WHETHER DECLARED, STATE OF OTHER GOVERNMENTAL REGULATIONS OR ANY OTHER ACT, CONTINGENCY OF BAR BEYOND THE CITY’S CONTROL.

2. CUSTOMER SHALL PAY SUCH FEES AND DEPOSITS AS SHALL BE ESTABLISHED BY THE TOWN AND SHALL FURTHER BE SUBJECT TO TERMINATION OF SERVICES UPON NON-PAYMENT OF FAILURE TO COMPLY WITH RULES, REGULATIONS, ORDINANCES OR LAWS AS ESTABLISHED BY THE TOWN. CUSTOMER ACKNOWLEDGES AND AGREES TO PAY CHARGES FOR THE SEWER, MINIMUM WATER CHARGES AND GARBAGE, EVEN IN THE EVENT THAT THE PREMISES ARE VACANT FOR EXTENDED PERIODS OF TIME, PROVIDED THAT THE CUSTOMER MAY ELIMINATE CHARGES ONLY BY REQUESTING THE TOWN TO TERMINATE SERVICES. UTILITY DEPOSITS WILL BE HELD WITHOUT INTEREST FOR AN INDEFINITE PERIOD OF TIME. CUSTOMER AGREES TO BE BOUND BY THE UTILITY SCHEDULE AND TO PAY APPLICABLE RATES AS ESTABLISHED BY THE TOWN COUNCIL. AT THIS TIME IT WILL BE APPLIED TO THE ACCOUNT, AND ANY UNUSED PORTION WILL BE REFUNDED.
3. THERE WILL BE A CHARGE ON ALL RETURNED CHECKS IN THE MAXIMUM AMOUNT ALLOWED BY STATE LAW, AND CUSTOMER AGREES TO PAY THE SAME.
4. UTILITY SERVICE IS SUBJECT TO TOWN ORDINANCES AND POLICIES, ESTABLISHED BY THE MAMMOTH TOWN COUNCIL.
5. THE TOWN REQUIRES FREE UNOBSTRUCTED ACCESS TO WATER METERS AT ALL TIME.

6. CO-SIGNER DOES HEREBY AGREE AND IS HEREBY BOUND AND IS EQUALLY LIABLE WITH CUSTOMER TO PAY THE TOWN ANY AMOUNTS BILLED PURSUANT TO THIS AGREEMENT.
7. IN THE EVENT CUSTOMER DEFAULTS IN PAYMENT, CO-SIGNER AGREES TO GIVE THE TOWN THE RIGHT TO ATTACH ANY DELINQUENT AMOUNTS TO CO-SIGNER'S PERSONAL UTILITY ACCOUNT. CO-SIGNER'S UTILITY SERVICE WILL BE SUBJECT TO DISCONNECTION, IF ACCEPTABLE ARRANGEMENTS ARE NOT MADE WITH THE TOWN TO PAY OFF SAID DELINQUENT AMOUNT.
8. IN THE EVENT THIS ACCOUNT IS PLACED WITH AN ATTORNEY FOR COLLECTION, EITHER WITH OR WITHOUT SUIT, CUSTOMER AND CO-SIGNER SHALL BE RESPONSIBLE FOR ALL COURT COSTS AND REASONABLE ATTORNEY'S FEES INCURRED THEREBY.
9. CUSTOMER AND CO-SIGNER IF ANY HEREBY WARRANT AND AFFIRM THAT THE INFORMATION PROVIDED IN THIS APPLICATION IS TRUE AND CORRECT TO THE BEST OF THEIR KNOWLEDGE. CUSTOMER AND CO-SIGNER ALSO AFFIRM, UNDERSTAND, AND AGREE TO COMPLY WITH PROVISIONS OF THIS UTILITY CONTRACT.
