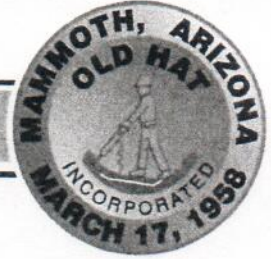

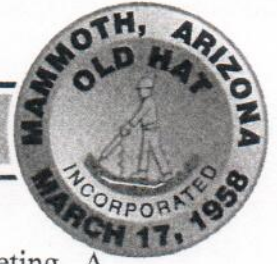
5. APPROVAL OF MINUTES
