WHEREAS, the Town Council and staff have developed a balanced budget, which is now presented as the Fiscal Year 2020 – 2021 Final Budget.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Town Council of the Town of Mammoth, Arizona that the Fiscal Year 2020 – 2021 Final Budget is adopted in the amount of \$5,300,411.
