The Town Council may hold an Executive Session, A.R.S. § 38-431.03 (A) (3) and (4) for legal advice, which will not be open to the public, to discuss any Agenda items set forth below.</u>

Due to the impacts of the COVID-19 pandemic, which have prompted declarations of a public health emergency at both the state and federal levels, this meeting will be conducted IN PERSON BY THE MAYOR AND TOWN COUNCIL using measures to protect public health. MEMBERS OF THE PUBLIC CANNOT ATTEND THE MEETING IN PERSON but can attend and listen to the meeting remotely by telephone.

Additionally, some items on the agenda may be shortened, continued to a future meeting or taken out of order.
